

# **UK Week in Markets**


# Week ending 29 August 2021



## **Key News and Events**



- The withdrawal of US troops and the ongoing evacuation of foreign citizens from Afghanistan took a deadly turn as ISIS-K's Kabul airport bombing killed more than 100 civilians and 13 US military personnel. In retaliation, the US launched drone strikes against the terror group to protect the Kabul evacuation effort.
- Eurozone business activity continued its strong momentum as the IHS Markit's eurozone flash composite purchasing managers' index (PMI) recorded 59.5 in August, slightly down from the previous month's 15year high of 60.2. However, US and UK businesses reported a sharp slowdown in activity due to ongoing supply constraints and labour shortages. In August, the flash US composite PMI fell to 55.4 from 59.9, and the flash UK composite PMI fell to 55.3 from 59.2.
- Reports suggest that Chinese regulators may be planning to ban foreign listing of internet companies that
  possess user-related data due to potential security risks, adding to the woes of the Chinese tech sector,
  which is already weighed down by regulatory concerns.
- The US Food and Drug Administration (FDA) granted full approval to the BioNTech/Pfizer Covid-19 vaccine, thus, making it the first vaccine to get full approval for use in people aged 16+.



**Cumulative Return Over Last 12 Months** 



#### **Equities**

- Global equity markets rose over the week.
- The MSCI AC World Index rose by 1.7% in local currency terms and rose by 1.1% in sterling terms.
- The Energy sector was the best performer, returning 5.4% in sterling terms.
- The Utilities sector was the worst performer, returning -2.7% in sterling terms.
- Emerging Market equities were the best performing market in sterling terms (+3.3%).
- European equities were the worst performing market in sterling terms (+0.6%).

#### **Government Bonds**

- The 10-year gilt yield rose by 6bps to 0.59% and the 20-year gilt yield rose by 7bps to 1.01%.
- The 10-year US treasury yield rose by 5bps to 1.31%.
- At the 10-year maturity, the German bund yield rose by 8bps to -0.41% and the French government bond yield rose by 10bps to -0.05%.
- Greek government bond yields rose by 14bps to 0.69%.
- The UK Over 5-year real yield fell by 4bps to -2.47% and the UK 20-year real yield fell by 2bps to -2.64%.
- 20-year breakeven inflation rose by 8bps to 3.57%.

#### Credit

- The sterling non-gilt spread over UK gilt yields (based on the ICE index) was unchanged at 90bps over the week.
- The US high yield bond spread over US treasury yields fell by 20bps to 317bps over the week.
- Meanwhile, the spread of hard currency emerging market debt over US treasury fell by 9bps to 348bps over the week. Local currency emerging market debt rose over the week, returning 0.8%.

## **Commodities**

- The S&P GSCI index rose by 7.0% in USD terms over the week.
- The S&P GSCI Energy index rose by 10.8% as the price of Brent Crude oil rose by 11.5% to US\$73/BBL.
- Industrial metal prices rose by 3.7% as copper prices rose by 4.8% to US\$9,352/MT.
- Agricultural prices rose by 2.3% and gold prices rose by 1.1% to US\$1,799/Oz.

## **Currencies**

- Sterling strengthened by 0.9% against the US dollar and was unchanged against the euro, ending the week at \$1.37/£ and €1.17/£ respectively.
- The US dollar increased by 0.2% against the Japanese yen, ending the week at ¥109.98/\$.
